#### **Business:**

- 1. Meeting called to order by Vice-Chairman McClure @ 4:00 pm. Welcome to all present.
- 2. Roll Call

# 8. Old Business

a. Regarding anticipated mold remediation; repairs; remodel and upgrades to District residence/office; the General Manager presented District Counsel opinion regarding competitive bidding requirements; project designation as a Public Works project and "Prevailing Wage" requirements.

Per District Counsel's opinion; cemetery districts are not obligated, under the State Contractor's Code, to go through a formal competitive bidding process. The Health & Safety Code requires the District to have policy regarding the purchase of equipment and supplies (capital improvements do not equate equipment and supplies).

Per Counsel opinion, District contract projects in excess of \$1,000 must include payment of "Prevailing Wage". Such projects must be treated as public works projects. The Board directed the General Manager to obtain a revised bid from Giffin & Crane, including the appropriate prevailing wages.

# 9. New Business

a. The Board directed the General Manager to mail Harry Fowler, P.E. a letter formally acknowledging the completion of his contract with the District as Project manager for the District's irrigation project.
