- **a.** General Manager Bower recommended "Cost of Living" pay increases for all full-time grounds employees, to match 12-month percentage change as of May 2024 BLS C.P. Index for this area, effective July 1. (February CPI 3.4%). The Board reviewed, discussed and approved of the increase as presented. Motion by Mr. Geller, second by Ms. Chyla. - **b.** General Manager Bower recommended changes to District fees and charges effective July 1. The Board reviewed, discussed, and approved of the change as presented. Motion by Ms. Chyla, second by Mr. Geller. Ayes: Chyla, Dressler, Geller. Motion carried.
- **c.** General Manager Bower requested consideration of extending District's Health/Vision/Dental coverage to full-time employees' "Immediate Dependents," with District covering 75% of premium for dependent coverage. The Board approved extending coverage by covering 100% of the premiums for dependents. Motion by Ms. Chyla, second by Mr. Geller. Ayes: Chyla, Dressler, Geller. Motion carried.
